The European Commission published its 'Europe's Beating Cancer Plan' roadmap in April this year<sup>1</sup>. In the section on early detection, screening programmes were highlighted as a valuable approach in preventing the most lethal cancer of all – lung cancer. In 2016, alone more than a quarter of a million people in the EU-28 died from this disease; it now accounts for about 20 percent of all cancer-related deaths. This represents 5.4 percent of all deaths in the EU, and is more than the combined number of deaths from colon, breast and prostate cancers all together.

The latest evidence from the NELSON trial<sup>2</sup> reinforces the findings of the earlier NLSC trial - up to 20 percent of lung cancer deaths can be prevented through screening, which helps detect nodules earlier. In the time between the publication of the NLST trial in 2005 and the NELSON trial in 2020, many critical questions regarding the design and implementation of lung screening programmes were addressed in a number of publications (see endnotes for examples). Pilot projects in the US, and Europe's own first-hand, real-life experiences, offer us a sound platform for discussion and decision-making on better approaches to lung cancer in Europe.

Given the available clinical evidence, the practical experience and the political momentum behind the Europe's Beating Cancer Plan, how can EU institutions help further develop and implement lung cancer screening programmes? What specific steps could be taken now? How can we use EU funds beyond health research in order to drive adoption of Lung Cancer Screening (LCS) in Member States? How do we design and execute best-in-class LCS programmes? What quality and training requirements do we need to successfully roll out LCS programmes in Member States?

#### **Prof. Hans-Ulrich KAUCZOR**

#### UNIVERSITY OF HEIDELBERG, EUROPEAN SOCIETY OF RADIOLOGY, GERMANY

Hans-Ulrich Kauczor studied medicine at the Universities in Bonn, Heidelberg and Cologne, Germany. After his graduation, he completed his residency in radiology and received his "Habilitation" degree at the University of Mainz in 1998. After having been an Associate Professor in Mainz he became full Professor for Radiology in 2003 and led the Department of Radiology at the German Cancer Research Center (DKFZ) in Heidelberg. Since 2008 he holds the positions of chairman of radiology and medical director of the Clinic of Diagnostic and Interventional Radiology at the University Hospital Heidelberg.

He is especially known for his clinical and scientific work applying computed tomography (CT) and magnetic resonance imaging (MRI) in the fields of chest diseases and oncology. He served as President of the European Society of Thoracic Imaging (2011), the German-Japanese Radiological Affiliation (2011-2013), the International Workshop of Pulmonary Functional Imaging (2011-2015) and the Fleischner Society (2015). He also served as chair of the research committee and member of the executive committee of the European Society of Radiology (2013-2016). Since 2018 he is Chair of the Translational Lung Research Center Heidelberg and member of the board of directors of the German Center of Lung Research (DZL).

#### LUNG CANCER EUROPE PRESIDENT, IRELAND

Dr. Anne-Marie Baird is a molecular biologist, who has worked extensively on mesothelioma and lung cancer. Her research interests are in inflammation, the metastatic cascade, drug resistance and disease biomarkers. She is currently a Senior Research Fellow in Trinity College Dublin, Ireland. Anne-Marie has been active in the lung cancer advocacy space since 2012 and was recently elected as the president of Lung Cancer Europe (LuCE). 
